

ScottishPower Solar and Battery Discount Offer Terms & Conditions

1. The promoter is ScottishPower Energy Retail Limited (company number SC190287), which has its registered office at 320 St. Vincent Street, Glasgow, G2 5AD (the “**Promoter**” or “**ScottishPower**”).
2. The promotion is the award of a discount (exclusive of VAT, if applicable) against the cost of a solar and battery system in accordance with these terms and conditions (these “**Terms**”) to Qualifying Applicants (as defined below) (the “**Promotion**”).
3. The Promotion will run for the period beginning on 11 March 2026 and shall continue until 15th April 2026 (the “**Promotion Period**”).
4. The Promotion is open to applicants who meet the following eligibility criteria (“**Qualifying Applicants**”). Qualifying Applicants must:
 - a. be legally resident in the UK (excluding Northern Ireland);
 - b. be the homeowner of the property at which the Solar and/or Battery System will be installed;
 - c. be aged 18 years or over; and
 - d. pay a deposit, in accordance with paragraph 5, for a ScottishPower Solar and/or Battery System (“**Solar and Battery System**”) during the Promotion Period (subject to agreeing to the **Solar, Battery & Heat Pump Solution and Related Services terms and conditions**). A grace period of 30 days will apply from the end of the Promotion Period for Solar and Battery System deposit payments to be completed. If the Solar and Battery System deposit payment falls outside this grace period, the Promoter shall exercise its discretion in whether to award the Discount (detailed in paragraph 5).
5. Subject to paragraph 8, all Qualifying Applicants will receive a discount of £250 (two hundred and fifty pounds sterling) on the final balance payment for an individual solar OR battery install, or £500 (five hundred pounds sterling) on the final balance due on their Solar AND Battery System, provided a fixed deposit of £250 (two hundred and fifty pounds sterling (for solar OR battery) or £500 (five hundred pounds sterling, (for solar AND battery) is paid initially, as specified in paragraph 4d (“**Discount**”). This will be reflected, as appropriate, on the customer’s proposal as a discount as follows: “Special Offer £250 discount” or “Special Offer £500 discount”.
6. The Promoter reserves the right to verify the eligibility of all Qualifying Applicants and to reject any applications that the Promoter believes to be duplicates, materially incorrect or fraudulent.
7. Any applications found to be transacting fraudulently with the Promoter will not be eligible for the Discount and may also have their details passed to police authorities for further investigation.
8. The Promoter reserves the right to prohibit the Promotion from being used in conjunction with any other ScottishPower promotional offer or affiliate promotional offer or staff offer during the Promotion Period at any time.
9. The Promoter accepts no responsibility for any inaccurate information provided by the Qualifying Applicant which results in the Discount not being applied in accordance with paragraph 5.
10. The Discount value is a fixed sum and is not subject to change based on any of the Qualifying Applicant’s specific circumstances.
11. Only one Discount will be applied per household in respect of this Promotion.
12. Without prejudice to paragraph 14, the Discount amount is not open for negotiation or reinterpretation.
13. The Promoter, its agents or distributors will not in any circumstances be responsible or liable to compensate any applicant or Qualifying Applicant or accept any responsibility or liability for any damage, loss, liability, personal injury or disappointment incurred or suffered by any applicant or Qualifying Applicant in connection with the Promotion except when any applicable law prohibits any exclusion of liability or responsibility.
14. By entering this Promotion, the applicant accepts these Terms. The Promoter reserves the right to refuse entry or refuse to award the Discount to anyone in breach of these Terms.
15. These Terms shall be governed by Scots law and shall be subject to the exclusive jurisdiction of the courts of Scotland.
