

ScottishPower 25% Discount on Solar Panel Offer Terms & Conditions

1. The promoter is ScottishPower Energy Retail Limited (company number SC190287), which has its registered office at 320 St. Vincent Street, Glasgow, G2 5AD (the “**Promoter**” or “**ScottishPower**”).
2. The promotion is the award of a 25% discount (exclusive of VAT, if applicable), for Qualifying Applicants (as defined in paragraph 4), off the cost of a solar panel or solar panel and battery system when installed by ScottishPower (the “**Promotion**”).
3. The Promotion will run for the period beginning on 28th May 2026 and shall continue until 16th July 2026 (the “Promotion Period”).
4. The Promotion is open to applicants who meet the following eligibility criteria (“Qualifying Applicants”). Qualifying Applicants must:
 - a. be legally resident in the UK (excluding Northern Ireland);
 - b. be the homeowner of the property at which the solar panel or solar panel and battery system will be installed;
 - c. be aged 18 years or over; and
 - d. pay a deposit, in accordance with paragraph 5, for a ScottishPower solar panel or solar panel and battery system during the Promotion Period (subject to agreeing to the **Solar, Battery & Heat Pump Solution and Related Services terms and conditions**). A grace period of 30 days will apply from the end of the Promotion Period for solar panel or solar panel and battery system deposit payments to be completed. If the deposit payment falls outside this grace period, the Promoter shall exercise its reasonable discretion in deciding whether to honour the Promotion.
5. Subject to paragraph 8, all Qualifying Applicants will receive a discount of 25% (twenty five percent) off the price of the Solar Panels ONLY (i.e. the discount does not apply to any other quoted costs) included in their proposal for between 1 and 16 panel systems. The discount will be applied within the overall price presented and this will be confirmed as follows: “Special Offer Panel Discount”.
6. The Promoter reserves the right to verify the eligibility of all Qualifying Applicants and to reject any applications that the Promoter believes to be duplicates, materially incorrect or fraudulent.
7. Any applications found to be transacting fraudulently with the Promoter will not be eligible for the discount and may also have their details passed to police authorities for further investigation.
8. The Promoter reserves the right to prohibit the Promotion from being used in conjunction with any other ScottishPower promotional offer or affiliate promotional offer or staff offer during the Promotion Period at any time.
9. The Promoter accepts no responsibility for any inaccurate information provided by the Qualifying Applicant which results in the discount not being applied in accordance with paragraph 5.
10. The discount value is a fixed sum and is not subject to change based on any of the Qualifying Applicant’s specific circumstances.
11. Only one discount will be applied per household in respect of this Promotion.
12. Without prejudice to paragraph 14, the discount amount is not open for negotiation or reinterpretation.
13. The Promoter, its agents or distributors will not in any circumstances be responsible or liable to compensate any applicant or Qualifying Applicant or accept any responsibility or liability for any damage, loss, liability, personal injury or disappointment incurred or suffered by any applicant or Qualifying Applicant in connection with the Promotion except when any applicable law prohibits any exclusion of liability or responsibility.
14. By entering this Promotion, the applicant accepts these Terms. The Promoter reserves the right to refuse entry or refuse to award the discount to anyone in breach of these Terms.

15. These Terms shall be governed by Scots law and shall be subject to the exclusive jurisdiction of the courts of Scotland.
